RESOLUTION OF THE TOWNSHIP OF LITTLE EGG HARBOR, COUNTY OF OCEAN, STATE OF NEW JERSEY, AUTHORIZING THE REVIEW AND APPROVAL OF ANNUAL COMPENSATION FOR LITTLE EGG HARBOR TOWNSHIP BOARD OF FIRE COMMISSIONERS, DISTRICT NO. 1

WHEREAS, if a Board of Fire Commissioners establishes annual compensation for its fire district commissioners, N.J.S.A. 40A:14-88 requires the municipal governing body to review and approve such compensation before the fire district can submit its annual budget to the voters; and

WHEREAS, the fire district must seek annual approval of elected commissioner compensation from the municipal governing body regardless of whether the Board is modifying the amount of compensation pursuant to Oughton v. Board of Fire Comrs., 178 N.J. Super. 565, 570-571 (App. Div. 1981); and

WHEREAS, in order for Fire District No. 1 to authorize its elected commissioners to receive compensation, the Board of Fire Commissioners adopted a Resolution, dated December 31, 2021, establishing the level of compensation; and

WHEREAS, the governing body hereby reviewed and desires to approve of the schedule of compensation for the Board of Fire Commissioners, District No. 1 in the Township of Little Egg Harbor.

NOW, THEREFORE, BE IT RESOLVED, by the governing body of the Township of Little Egg Harbor, County of Ocean, State of New Jersey as follows:

1. That the governing body does hereby approve of the proposed annual compensation for the Fire Commissioners for District No. 1 as set forth on the attached Schedule A.

Establishing the Compensation for Members of the Board of Fire Commissioners


