

**RESOLUTION NO. 2022-066**

**RESOLUTION OF THE TOWNSHIP OF LITTLE EGG HARBOR, COUNTY OF OCEAN, STATE OF NEW JERSEY, CANCELLING TAXES AND AUTHORIZING A REFUND PURSUANT TO N.J.S.A. 54:4-3.30**

**WHEREAS, N.J.S.A. 54:4-3.30** provides for an exemption from property taxes on certain property owned by a totally-disabled Veteran; and

**WHEREAS,** it has been determined by the Tax Assessor that the property located at Block 326.26, Lot 41 owned by Thomas J. Gaynor qualifies for a Veteran's Property Tax Exemption; and

**WHEREAS,** pursuant to N.J.S.A. 54:4-3.32 the Township Committee has the authority to cancel charges for a totally-disabled veterans portion of the 2021 taxes when a N.J.S.A. 54:4-3.30 Certification of Assessment Credit for Exemption has been granted; and

**WHEREAS,** in this case the Tax Collector deems that the property owner should receive a refund on taxes already paid for the year 2021.

**NOW, THEREFORE, BE IT RESOLVED,** by the governing body of the Township of Little Egg Harbor, County of Ocean, State of New Jersey to hereby authorize a Veteran's Property Tax Exemption discharge of debt for the 2021 taxes in the amount of \$410.59; and a refund of \$410.59 which shall be payable to the mortgage company; and that a certified copy of this resolution shall be forwarded to the Tax Collector.



WHEREAS, the Tax Collector has requested authorization to cancel property taxes for 2021 based upon a prorated assessment of \$293,100 multiplied by the F02 Tax Rate, taxes outstanding that would otherwise be exempt.
