**RESOLUTION OF THE TOWNSHIP OF LITTLE EGG HARBOR, COUNTY OF OCEAN, STATE OF NEW JERSEY, AWARDING A CONTRACT FOR TWO (2) 2021 OR NEWER MACK LR (OR EQUAL) SIDE LOADER WITH DUAL SIT DOWN CAB TO BERGEY'S TRUCKS, INC. D/B/A BERGEY'S TRUCK CENTERS**

**WHEREAS**, the Township of Little Egg Harbor duly advertised for the receipt of bids for two (2) 2021 or newer Mack LR Side Loader with Dual Sit Down Cab or approved equal; and

**WHEREAS**, in response to the invitation to bidders, one (1) bid was received on May 26, 2021; and

**WHEREAS**, the bid has been reviewed by the Township and it has been determined that Bergey's Trucks, Inc. d/b/a Bergey's Truck Centers, submitted the lowest responsible bid in accordance with the bid specifications, said bid being \$623,254.00; and

**WHEREAS**, it is the desire of the governing body to award a contract for two (2) 2021 or newer Mack LR Side Loader with Dual Sit Down Cab or approved equal to Bergey's Trucks, Inc. d/b/a Bergey's Truck Centers.

**NOW, THEREFORE, BE IT RESOLVED**, by the governing body of the Township of Little Egg Harbor, County of Ocean, State of New Jersey as follows:

1. That the governing body does hereby award a contract for two (2) 2021 or newer Mack LR Side Loader with Dual Sit Down Cab or approved equal to Bergey's Trucks, Inc. d/b/a Bergey's Truck Centers, at \$623,254.00, which sum represents \$311,627.00 per each Side Loader.


