**RESOLUTION OF THE TOWNSHIP OF LITTLE EGG HARBOR, COUNTY OF OCEAN, STATE OF NEW JERSEY, AUTHORIZING THE APPOINTMENT OF BRYCE HAYEK AS LABORER 1, CLEAN COMMUNITIES (SEASONAL) FOR THE DEPARTMENT OF PUBLIC WORKS**

**WHEREAS**, the Little Egg Harbor Department of Public Works is in need of a person to fill the position of Laborer 1, Clean Communities (Seasonal) in the Department of Public Works; and

**WHEREAS**, Bryce Hayek satisfies the job specifications for the title of Laborer 1, Clean Communities (Seasonal) and the Township interim Administrator has recommended the appointment of Bryce Hayek as Laborer 1, Clean Communities (Seasonal); and

**WHEREAS**, the Township Committee wishes to appoint Bryce Hayek as Laborer 1, Clean Communities (Seasonal) for the Department of Public Works.

**NOW, THEREFORE, BE IT RESOLVED**, by the governing body of the Township of Little Egg Harbor, County of Ocean, State of New Jersey:

1. That Bryce Hayek is appointed to the position of Laborer 1, Clean Communities (Seasonal) for the Department of Public Works, retroactive to August 11, 2021.
2. That Bryce Hayek shall each be compensated at a rate of \$14.00 an hour as a Laborer 1, Clean Communities (Seasonal) in accordance with the Township Salary Ordinance and under the Clean Communities Grant.
3. That a certified copy of this Resolution shall be forwarded by the Municipal Clerk to the Township Administrator, Superintendent of Public Works, Chief Financial Officer, and Bryce Hayek.
