**RESOLUTION OF THE TOWNSHIP OF LITTLE
EGG HARBOR, COUNTY OF OCEAN, STATE OF
NEW JERSEY, EXTENDING THE STATUTORY
GRACE PERIOD OF THE THIRD QUARTER 2021
TAX BILLS**

WHEREAS, the governing body of the Township of Little Egg Harbor recognizes the devastating impact of the Public Health Emergency and State of Emergency caused by the COVID-19 pandemic, and therefore wishes to provide an extended grace period for the payment of Third Quarter 2021 taxes.

NOW, THEREFORE, BE IT RESOLVED, by the governing body of the Township of Little Egg Harbor, County of Ocean, State of New Jersey as follows:

1. That an extended "grace period" is hereby established for the payment of the Third Quarter 2021 taxes due to Township of Little Egg Harbor.
2. That an extension to the grace period for quarterly property taxes be established to August 23, 2021, during which time interest charges will not be assessed. However, taxes not paid by August 23, 2021 will be charged interest from the original due date of August 1, 2021.
3. In accordance with N.J.S.A. 54:4-67 as amended, the rate of interest to be charged for the nonpayment of taxes on or before the date when they would become delinquent is hereby fixed at eight percent (8%) per annum on the first \$1,500.00 of the delinquency and eighteen percent (18%) per annum on any amount in excess of \$1,500.00, to be calculated from the date the tax was payable until the date of actual payment, and if the delinquency is in excess of \$10,000 and remains in arrears beyond December 31st, an additional penalty of six percent (6%) shall be charged against the delinquency. In accordance with N.J.S.A. 54:4-67, no interest shall be charged if payment of any installment is made within the tenth calendar day following the date upon which the same became payable.


