**RESOLUTION OF THE TOWNSHIP OF LITTLE
EGG HARBOR, COUNTY OF OCEAN, STATE OF
NEW JERSEY, AWARDED A CONTRACT FOR
LEHT RECREATION SOCCER AND FOOTBALL
FIELD RECONSTRUCTION TO AMERICAN
ATHLETIC COURTS INC. (BASE BID AND
ALTERNATE BID "B")**

WHEREAS, the Township of Little Egg Harbor duly advertised for the receipt of bids for LEHT Recreation Complex Soccer and Football Field Reconstruction; and

WHEREAS, in response to the invitation to bidders, four (4) bids were received on September 3, 2021; and

WHEREAS, the bid has been reviewed by the Township and it has been determined that American Athletic Courts, Inc., submitted the lowest responsible bid in accordance with the bid specifications, said bid being Base Bid with Alternate Bid "B" at \$1,546,831.90, which represents \$1,917,993.50 for reconstruction of existing soccer and football fields, including stripping, underdrain improvements, soil amendments, laser grading, irrigation improvements, topsoiling and sodding, and subtracts \$371,161.60 for Alternate Bid "B" which eliminates the proposed 5" drainage stone layer below the topsoil; and

WHEREAS, it is the desire of the governing body to award a contract for LEHT Recreation Complex Soccer and Football Field Reconstruction to American Athletic Courts, Inc. a/k/a American Athletic Track and Turf.

NOW, THEREFORE, BE IT RESOLVED, by the governing body of the Township of Little Egg Harbor, County of Ocean, State of New Jersey as follows:

2. That the Mayor and the Township Clerk are hereby authorized to execute a contract with American Athletic Courts, Inc., in accordance with the bid submitted by American Athletic Courts, Inc.

3. That the governing body specifically approves the bid specifications, designs and plans prepared in connection with the LEHT Recreation Complex Soccer and Football Field Reconstruction Project.




