

RESOLUTION NO. 2021-248

A RESOLUTION OF THE TOWNSHIP OF LITTLE EGG HARBOR, COUNTY OF OCEAN, STATE OF NEW JERSEY, SUPPORTING THE OCEAN COUNTY NATURAL LANDS TRUST PROPOSAL TO ACQUIRE BLOCK 263, LOT 8, IN THE TOWNSHIP OF LITTLE EGG HARBOR FOR OPEN SPACE PRESERVATION BY THE COUNTY OF OCEAN

WHEREAS, property known as Block 263, Lot 8, on the Tax Map of the Township of Little Egg Harbor, also known as Giffords Mill Branch, has been identified by Ocean County Natural Lands Trust as property which should be acquired for open space; and

WHEREAS, the County of Ocean intends to acquire title to Block 263, Lot 8, from the current property owners, C. Russell & Zeeta Horner and have reached an agreement; and

WHEREAS, the Little Egg Harbor Township Natural Lands Trust committee has reviewed the property and supports the acquisition of Block 263, Lot 8 for open space preservation by the County of Ocean; and

WHEREAS, the Township of Little Egg Harbor supports the acquisition of Block 263, Lot 8 in the Township of Little Egg Harbor by the County of Ocean for open space and recreational purposes in accordance with N.J.S.A. 40:12-15.1 et seq.

NOW, THEREFORE, BE IT RESOLVED by the governing body of the Township of Little Egg Harbor, County of Ocean, and State of New Jersey, as follows:

1. That the governing body does hereby support the acquisition of Block 263, Lot 8, on the Tax Map of the Township of Little Egg Harbor, by the County of Ocean for open space and recreational purposes in accordance with N.J.S.A. 40:12-15.1 et seq.
2. That a certified copy of this resolution shall be forwarded to the Township Natural Lands and Trust Committee, the Township Engineer, Ocean County Natural Lands Trust, the
