

RESOLUTION NO. 2021 – 66

RESOLUTION OF THE TOWNSHIP OF LITTLE EGG HARBOR, COUNTY OF OCEAN, STATE OF NEW JERSEY, DESIGNATING DANIEL SAHIN, ESQUIRE, TO ACT AS ALTERNATE JUDGE OF THE SINGLE JOINT MUNICIPAL COURT OF THE TOWNSHIP OF LITTLE EGG HARBOR AND THE TOWNSHIP OF EAGLESWOOD IN ACCORDANCE WITH A SHARED SERVICES AGREEMENT

WHEREAS, N.J.S.A. 2B:12-1 provides that two or more municipalities may enter into an agreement establishing a single joint municipal court and provide for its administration; and

WHEREAS, the Township of Little Egg Harbor and the Township of Eagleswood entered into a Shared Services Agreement pursuant to N.J.S.A. 40A:65-4 for a single joint municipal court by Resolution 2018-158; and

WHEREAS, according to that Agreement, Little Egg Harbor Township has the sole discretion to appoint the Municipal Court Alternate Judge for the single joint municipal court; and

WHEREAS, Little Egg Harbor Township had previously appointed Daniel Sahin, Esq. as Alternate Judge of the Municipal Court of the Township of Little Egg Harbor by Resolution 2020-98 for a three (3) year term commencing April 21, 2020 and ending April 22, 2023; and

WHEREAS, it is the desire of the governing body to designate Daniel Sahin, Esq. as the Alternate Judge of the Municipal Court of the Township of Eagleswood, in accordance with the Shared Service Agreement for a joint municipal court.

NOW, THEREFORE, BE IT RESOLVED, by the governing body of the Township of Little Egg Harbor, County of Ocean, State of New Jersey as follows:
