**RESOLUTION OF THE TOWNSHIP OF LITTLE EGG HARBOR, COUNTY OF OCEAN, STATE OF NEW JERSEY, SETTING THE RATE OF PAY FOR ON CALL PER DIEM TELECOMMUNICATORS AND ON CALL PER DIEM TELECOMMUNICATOR TRAINEES FOR THE TOWNSHIP OF LITTLE EGG HARBOR POLICE DEPARTMENT**

**WHEREAS**, the Township of Little Egg Harbor is in need of on call per diem Telecommunicators and on call per diem Telecommunicator Trainees for the Little Egg Harbor Township Police Department; and

**WHEREAS**, the governing body wishes to set the rate of pay for on call per diem Telecommunicator Trainees during the training period of 240 hours and a rate of pay for on call per diem Telecommunicators for the Township Police Department.

**NOW, THEREFORE, BE IT RESOLVED**, by the governing body of the Township of Little Egg Harbor, County of Ocean, State of New Jersey, as follows:

1. That during the training period of the first 240 hours, on call per diem Telecommunicators Trainees for the Little Egg Harbor Township Police Department shall be compensated at a rate of \$17.00 per hour, in accordance with the Township Salary Ordinance.

2. . That after the training period of the first 240 hours, on call per diem Telecommunicators for the Little Egg Harbor Township Police Department shall be compensated at a rate of \$18.00 per hour, in accordance with the Township Salary Ordinance.

3. That this Resolution shall be effective immediately.

4. That a certified copy of this resolution shall be forwarded to the Chief Financial Officer and the Chief of Police.
