

RESOLUTION NO. 2021 – 82

**RESOLUTION OF THE TOWNSHIP OF LITTLE
EGG HARBOR, COUNTY OF OCEAN, STATE OF
NEW JERSEY, ESTABLISHING FEES FOR THE
EMPLOYMENT OF OFF-DUTY POLICE OFFICER
BY PRIVATE PERSONS OR ENTITIES**

WHEREAS, Section 93-13 of the Township Code of the Township of Little Egg Harbor provides for the retention of off-duty police officers of the Township of Little Egg Harbor by non-Township persons or entities; and

WHEREAS, the Chief of Police is empowered to enter into contracts with private entities pursuant to which the entity shall pay to the Treasurer of the Township an hourly sum that is fixed by Resolution of the governing body; and

WHEREAS, 90% of the fee shall be remitted to the member of the Police Department performing the duties and 10% of the fee shall be retained by the Township for administrative expenses, pursuant to the terms of Section 93-13; and

WHEREAS, the intent of this Resolution is to supersede any prior Resolutions establishing said fees, except it shall not affect pre-existing agreements with private entities in effect as of the date of the approval of this Resolution; and

WHEREAS, for non-holidays, the fee for police officers performing off-duty police activities for any person or entities shall be equal to 1.5 times the hourly rate for a 20-year patrolman, said hourly rate in accordance with the applicable collective bargaining agreement in effect at the time of the performance of the off-duty activities for any person or entities, and for the following holidays, the fee for police officers performing off-duty police

activities for any person or entities shall be equal to 2 times the hourly rate for a 20-year patrolman, said hourly rate in accordance with the applicable collective bargaining agreement in effect at the time of the performance of the off-duty activities:

New Year's Day	Martin Luther King's Birthday	Lincoln's Birthday
President's Day	Good Friday	Easter Sunday
Memorial Day	Fourth of July	Labor Day
Columbus Day	Election Day	Veterans Day
Thanksgiving Day	Day after Thanksgiving	Christmas Day

NOW, THEREFORE, BE IT RESOLVED, by the governing body of the Township of Little Egg Harbor, County of Ocean, State of New Jersey as follows:

1. That the fee for police officers performing off-duty police activities for any person or entities shall be equal to 1.5 times the hourly rate for a 20-year patrolman, said hourly rate in accordance with the applicable collective bargaining agreement in effect at the time of the performance of the off-duty activities, and for the holidays noted above, the fee for police officers performing off-duty police activities for any person or entities shall be equal to 2 times the hourly rate for a 20-year patrolman, said hourly rate in accordance with the applicable collective bargaining agreement in effect at the time of the performance of the off-duty activities.
2. Any prior Resolutions adopted by the governing body which set the aforesaid hourly rates in accordance with Township Code §93-13 are

superseded as of the effective date of this Resolution, except this Resolution shall not affect pre-existing agreements with private entities in effect as of the date of the approval of this Resolution.

3. This Resolution shall remain in effect unless and until the governing body adopts a subsequent, superseding Resolution as to hourly rates.
