**RESOLUTION OF THE TOWNSHIP OF LITTLE EGG HARBOR, COUNTY OF OCEAN, STATE OF NEW JERSEY, AUTHORIZING ASSIGNMENT OF TAX SALE CERTIFICATE #21-00269**

**WHEREAS**, N.J.S.A. 54:5-113, authorizes assignment by a municipality of Tax Sale Certificates for the full amount of the certificate(s), including all subsequent municipal taxes and other municipal charges; and


**ASSIGNMENT OF TAX SALE CERTIFICATE**


