RESOLUTION OF THE TOWNSHIP OF LITTLE EGG HARBOR, COUNTY OF OCEAN, STATE OF NEW JERSEY AUTHORIZING THE SUBMISSION OF AN APPLICATION TO THE SUSTAINABLE JERSEY GRANT PROGRAM FOR A GRANT FOR YEAR 2022 TO CONSTRUCT A BICYCLE AND PEDESTRIAN IMPROVEMENT PROJECT ALONG RADIO ROAD
