

**RESOLUTION NO. 2022-113**

**RESOLUTION OF THE TOWNSHIP OF LITTLE EGG HARBOR,  
COUNTY OF OCEAN, STATE OF NEW JERSEY AMENDING  
RESOLUTION 2021-099 SO AS TO CLARIFY THE AFFECTED  
SEGMENT OF COUNTY ROAD 103 (CENTER STREET)  
REGARDING THE ESTABLISHMENT OF A FOUR (4) TON  
WEIGHT LIMIT**

**WHEREAS**, on April 8, 2021, by Resolution 2021-099, the governing body supported the application by the County of Ocean to New Jersey Department of Transportation for street intersection improvements and four (4) ton weight limit on Center Street to Route 9; and

**WHEREAS**, on March 10, 2022, the Office of the Ocean County Engineer advised that the New Jersey Department of Transportation supported the request and recommended approval of the establishment of a four (4) ton weight limit restriction along CR #103 (Center Street); and

**WHEREAS**, the Ocean County Engineer indicated that before finalizing documentation with the New Jersey Department of Transportation, an amendment to Resolution 2021-099 was requested to reflect that the affected segment was within the Township's jurisdiction from Oak Lane to the boundary with Tuckerton Borough; and

**WHEREAS**, it is the desire of the governing body to amend Resolution 2021-099 so as to clarify that the establishment of a 4-Ton Weight Limit restriction is requested only to the affected segment of CR #103 (Center Street) from Oak Lane to the Tuckerton Borough Boundary, which is under the jurisdiction of the Township.


**NOW, THEREFORE, BE IT RESOLVED** by the Mayor and Township Committee of the Township of Little Egg Harbor, County of Ocean, State of New Jersey, as follows:

1. That Resolution 2021-99 is hereby amended to clarify that the establishment of a 4-Ton Weight Limit restriction is requested only to the affected segment of CR #103 (Center Street) from Oak Lane to the Tuckerton Borough Boundary, which is under the jurisdiction of the Township.

2. That a certified copy of this resolution be forwarded to the County of Ocean, the Ocean County Engineer, and the Borough of Tuckerton.
