

RESOLUTION NO. 2022-176

RESOLUTION OF THE TOWNSHIP OF LITTLE EGG HARBOR, COUNTY OF OCEAN, STATE OF NEW JERSEY, UPDATING AND ESTABLISHING ROTATING LIST OF TOWING CONTRACTORS PURSUANT TO TOWNSHIP CODE, CHAPTER 309, TOWING AND STORAGE

WHEREAS, pursuant to Township Code, Chapter 309, Towing and Storage, the Township of Little Egg Harbor established a rotating list of towing and storage contractors to provide vehicle towing and storage services; and

WHEREAS, the Chief of Police is responsible for the administration of said rotating list pursuant to § 309-1, 'Rotating list of towing contractors established'; and

WHEREAS, the current rotating list of towing and storage contractors as established by the Chief of Police includes Master Craft Towing as an authorized provider; and

WHEREAS, Master Craft has requested that it be removed from the rotating list of towing and storage contractors by memorandum dated June 8, 2022, attached hereto as Exhibit A; and

WHEREAS, the governing body desires to update the rotating list of towing and storage contractors so as to remove Master Craft as an eligible contractor and re-establish the rotating list with the active contractors as delineated on Exhibit B, attached hereto.

NOW, THEREFORE, BE IT RESOLVED, by the governing body of the Township of Little Egg Harbor, County of Ocean, State of New Jersey as follows:

1. That the request of Master Craft Towing to be removed from the rotating list of towing and storage contractors to provide vehicle towing and



storage services is accepted and Master Craft Towing will be removed from the rotating list of eligible towing and storage contractors.

2. That the rotating list of towing and storage contractors as administered by the Chief of Police is ratified and is attached hereto as Exhibit B.
3. That any previous resolution establishing a rotating list of towing and storage contractors and terms and conditions thereto is hereby superseded by this Resolution.
4. That the contractors on the rotating list as noted in the attached Exhibit B must comply with all the provisions of Chapter 309, Towing and Storage.
5. That this Resolution shall take effect immediately.
6. That a certified copy of this resolution be forwarded to the Chief Financial Officer, the Chief of Police, Master Craft Towing, Charlie's Auto Body, and Streamline Auto Body.
