

**ORDINANCE NO. 2022-11**

**AN ORDINANCE OF THE TOWNSHIP OF LITTLE EGG HARBOR, COUNTY OF OCEAN, STATE OF NEW JERSEY, AMENDING AND SUPPLEMENTING CHAPTER 156, CERTIFICATES OF OCCUPANCY**

**NOW, THEREFORE, BE IT ORDAINED**, by the governing body of the Township of Little Egg Harbor, County of Ocean, State of New Jersey, as follows:

**SECTION 1.** That the governing body hereby amends Chapter 156, Certificates of Occupancy, Article I, Rental Units, so as to amend **§ 156-9, Fees, Subsection A** in its entirety as follows:

**§ 156-9 Fees**

**A.** The owner of the inspected property shall be charged a fee for each inspection as follows:

- (1) Each dwelling unit: \$50. Any subsequent inspection that is required shall cost an additional \$30 per re-inspection.
- (2) Boarding houses:
  - (a) One (1) to five (5) rooms: \$20.
  - (b) Six to 15 rooms: \$25.
  - (c) Sixteen to 25 rooms: \$30.
  - (d) Twenty-six to 35 rooms: \$40.
  - (e) Thirty-six or more rooms: \$50.

Any required subsequent re-inspection for any of the above shall cost an additional fee per re-inspection of 50% of the initial fee (i.e. re-inspection of a thirty-six (36) or more room boarding house shall cost \$25).

- (3) Any unit not used for living or sleeping purposes, and used for commercial, business or any other purpose: \$75. Any subsequent inspection that is required shall cost an additional \$50 per re-inspection.

**SECTION 2.** That the governing body hereby amends Chapter 156, Certificates of Occupancy, Article II, Acquisition Prior to Transfer of Title, so as to amend § **156-11, Fees for inspections**, in its entirety as follows:

**§ 156-11 Fees for inspections**

The fee for initial inspection as required by § **156-10** hereof shall be \$60 per dwelling unit, and \$75 for any other commercial or business unit. Any subsequent inspection that is required shall cost an additional \$30 per re-inspection per residential dwelling unit and \$50 per re-inspection of any other commercial or business unit.

**SECTION 3.** That the governing body hereby amends Chapter 156, Certificates of Occupancy, Article II, Acquisition Prior to Transfer of Title, so as to amend § **156-12.1, Temporary waiver of certificate of occupancy**, so as to omit the phrase “fee of \$25” and replace it with “fee of \$60.”

**SECTION 4.** All ordinances or parts of ordinances inconsistent herewith are hereby repealed.

**SECTION 5.** If any section, subsection, sentence, clause, phrase or portion of this ordinance is for any reason held to be invalid or unconstitutional by a court of competent jurisdiction, such portion shall be deemed a separate, distinct and independent provision, and such holding shall not affect the validity of the remaining portions hereof.
