**RESOLUTION OF THE TOWNSHIP OF LITTLE EGG
HARBOR, COUNTY OF OCEAN, STATE OF NEW
JERSEY, ACCEPTING THE RETIREMENT OF AND
AUTHORIZING THE COMPENSATION OF
ACCUMULATED TIME TO TROY BEZAK**

WHEREAS, Troy Bezak has submitted his retirement from the Township as of November 1, 2022; and

WHEREAS, as of the date of his retirement, Troy Bezak will have accumulated 1766.75 hours of unused time over the course of his employment with Little Egg Harbor Township; and

WHEREAS, Troy Bezak is entitled compensation for unused vacation time of 440 hours for a total of \$41,483.20; unused sick time of 1300 hours for a total of \$18,000 pursuant to the applicable collective bargaining agreement; unused personal time of 13.25 hours for a total of \$1,249.21; and unused comp time of 13.50 hours for a total of \$1,272.78. Mr. Bezak requested \$41,000.00 be sent to his deferred compensation provider November 2022 and the remaining balance paid January 2023.

NOW, THEREFORE, BE IT RESOLVED, by the governing body of the Township of Little Egg Harbor, County of Ocean, State of New Jersey as follows:

1. That the governing body does hereby authorize the payment to Troy Bezak of \$62,005.19 for unused accumulated time \$41,000.00 be paid to his deferred compensation provider in November 2022 and the remaining balance to be paid January 2023 to his deferred compensation provider.
2. That a certified copy of this resolution shall be forwarded to Troy Bezak, the State Department of Personnel, and the Chief Financial Officer.
