WHEREAS, N.J.S.A. 54:5-113, authorizes assignment by a municipality of Tax Sale Certificates for the full amount of the certificate(s), including all subsequent municipal taxes and other municipal charges; and

ASSIGNMENT OF TAX SALE CERTIFICATE


