**RESOLUTION OF THE TOWNSHIP OF LITTLE EGG HARBOR, COUNTY OF OCEAN, STATE OF NEW JERSEY, APPOINTING DANIEL SAHIN, ESQUIRE AS JUDGE OF THE MUNICIPAL COURT OF THE TOWNSHIP OF LITTLE EGG HARBOR AND FOR THE TOWNSHIP OF EAGLESWOOD IN ACCORDANCE WITH A SHARED SERVICES AGREEMENT**

**WHEREAS**, Daniel Sahin, Esq. was previously appointed to fill the unexpired term of the previous Municipal Court Judge; and

**WHEREAS**, Daniel Sahin, Esq is currently serving as Municipal Court Judge for the Township of Little Egg Harbor and Township of Eagleswood, with said term expiring April 22, 2023; and

**WHEREAS**, the Township desires to appoint Daniel Sahin, Esq., to the position of Judge of the Municipal Court for the Township of Little Egg Harbor for a three-year term from April 22, 2023 to April 22, 2026, in accordance with N.J.S.A. 2B:12-4 and Township Code §22-4; and

**WHEREAS**, the Township of Little Egg Harbor and the Township of Eagleswood entered into a Shared Services Agreement pursuant to N.J.S.A. 2B:12-1 and N.J.S.A. 40A:65-4 for a municipal court by Resolution 2018-158; and

**WHEREAS**, according to that Agreement, Little Egg Harbor Township has the sole discretion to appoint the Municipal Court judge for the municipal court; and

**WHEREAS**, it is the desire of the governing body to further appoint Daniel Sahin, Esq. as the Judge of the Municipal Court of the Township of Eagleswood, in accordance with the Shared Service Agreement for a municipal court between Little Egg Harbor Township and Eagleswood Township.

**NOW, THEREFORE, BE IT RESOLVED**, by the governing body of the Township of Little Egg Harbor, County of Ocean, State of New Jersey as follows:

1. That the governing body does hereby appoint Daniel Sahin, Esq., the Judge of the Municipal Court of Little Egg Harbor Township for a three (3) year term, commencing on April 22, 2023 and ending on April 22, 2026, in accordance with N.J.S.A. 2B:14-4 and §22-4 of the Township Code of Little Egg Harbor Township.
2. That the salary for the Judge of the Municipal Court shall be \$53,872 annually. The Judge shall be paid \$1000.00 for each additional court session, if needed, up to a maximum of six (6) session in a twelve (12) month period.
3. That the governing body does hereby further appoint Daniel Sahin , Esq., the Judge of the Municipal Court of Eagleswood Township, pursuant to the Shared Services Agreement between the Township of Little Egg Harbor and Township of Eagleswood authorized by Resolution 2018-158, for the three (3) year term commencing April 22, 2023, and ending on April 22, 2026.
4. That a certified copy of this resolution shall be forwarded to the Little Egg Harbor Township Court Administrator, Chief Financial Officer, Daniel Sahin , Esq., the Township of Eagleswood Court Administrator, and the Administrative Office of the Courts.
