RESOLUTION NO. 2019 – 63

RESOLUTION OF THE TOWNSHIP OF LITTLE EGG HARBOR, COUNTY OF OCEAN, STATE OF NEW JERSEY, AUTHORIZING THE SUBMISSION OF AN APPLICATION TO THE OCEAN COUNTY COMMUNITY DEVELOPMENT BLOCK GRANT PROGRAM

WHEREAS, the Ocean County Community Development Block Grant (CDBG) Program provides funds for economic development, housing rehabilitation, and community revitalization in public facilities designated as limited to people of low and moderate income or to address recent local needs for which no other source of funding is available; and

WHEREAS, the Township of Little Egg Harbor desires to apply for a \$50,000 grant from the County of Ocean for the Little Egg Harbor Community Center Rehabilitation; and

WHEREAS, the Township has held public hearings prior to the submission of the application, the last hearing being held on January 10, 2019; and

WHEREAS, the Township desires to submit an application to the Ocean County CDBG Program for a Community Development Block Grant in the amount of \$50,000 for the Little Egg Harbor Community Center Rehabilitation.

NOW, THEREFORE, BE IT RESOLVED, by the governing body of the Township of Little Egg Harbor, County of Ocean, State of New Jersey as follows:

1. That the Mayor is hereby authorized to execute and the Municipal Clerk to attest to the application to the Ocean County CDBG Program for a Community Development Block Grant in the amount of \$50,000 for the Little Egg Harbor Community Center Rehabilitation.
2. That the Mayor is authorized to execute and the Municipal Clerk to attest to any and all other related documents required by Ocean County Housing and Urban Development with regard to said application.
3. That a certified copy of this resolution shall be forwarded to the Township Engineer and the Ocean County CDBG Program.
