May 2018: 98 Animal Control Calls, 96 patrols were conducted, 78 Investigations were conducted; 8 NOV'S, 4 Summonses were issued. Captured were Dogs of many breeds, Cats, 2 Ducks, a Goose, Raccoons, Opossums, a Skunk, and a Seagull.
