Blue Bird Trail: Robert Burr updated Commission

1. Question was asked if the birds will be banded this year and the answer was yes.
2. On February 13, 2018 8 boxes were checked. Freedom Fields 4 boxes intact and ready however some brush needs to be cut back.
3. Sports Complex boxes 1, 3 and 4 are ready however box 2 needs a little care and have to reset the floor.
4. 4 boxes placed by Boy Scouts around the pond at Freedom Fields need to be cleaned out.
5. Letter needs to go to Mike Magnum advising the Commission is restarting nest monitoring and banding at the 4 Commission boxes in Freedom Fields.
6. Breeding for birds starts March
7. Every other week bird boxes need to be checked
8. March meeting need to set up schedule to monitor boxes.
