RE: Mystic Island West Maintenance Dredging Project Phase 1

Dear Property Owner:

As you may be aware, the Township of Little Egg Harbor recently completed two successful lagoon dredging projects for Osborn Island and Mystic Island East. These projects were a joint effort between the Township, the Osborn Island Residents Association, as well as the affected property owners and have had positive results. Given these successes, and in the interest of continuing to move the Township in a positive direction, the Township has secured permits to dredge the remainder of waterfront lagoons/creeks throughout the Township.

Accordingly, we would like to meet with you and discuss the possibility of a similar project in your neighborhood. We note that all costs for a dredging project would be included in a special assessment for all waterfront properties benefitting from the dredging project. Please be advised that bathymetric surveys have confirmed that 107,700 cubic yards of material are required to achieve a 4.5 foot depth in the main channels at low tide in your area, and we estimate the work to cost \$75/CY. That means that a special assessment over 10 years would cost approximately \$650.00/year per property; again we note that these are preliminary estimates only.

The Township has scheduled a series of special virtual meetings to explain the details of the project for your neighborhood, and we invite you to the meeting to be held on Tuesday March 16, 2021 at 7:30 P.M.
