

ORDINANCE NO. 2020-13

AN ORDINANCE OF THE TOWNSHIP OF LITTLE EGG HARBOR, COUNTY OF OCEAN, STATE OF NEW JERSEY, AMENDING CHAPTER 151 OF THE TOWNSHIP CODE OF THE TOWNSHIP OF LITTLE EGG HARBOR, ENTITLED "BULKHEAD CONSTRUCTION"

BE IT ORDAINED, by the governing body of the Township of Little Egg Harbor, County of Ocean, State of New Jersey, as follows:

SECTION 1. The Township Code of the Township of Little Egg Harbor is hereby amended and supplemented so as to amend Chapter 151, entitled "Bulkhead Construction," so as to amend §151-5 entitled "Conformance to standards", Subsection F, in its entirety as follows:

§151-5 Conformance to Standards

F. All development on waterfront properties abutting lagoons shall provide for marine bulkheading along the entire lagoon frontage. Only marine bulkheads are permitted along such lagoon frontages; in no case shall bank slopes, riprap, revetments, sod, vegetated, or other types of bank stabilization be permitted. If the requirements of the New Jersey Department of Environmental Protection do not permit marine bulkheading along the entire lagoon frontage, then the Department's determination on stabilization type shall govern.

SECTION 2. All ordinances or parts of ordinances inconsistent herewith are hereby repealed.

SECTION 3. If any section, subsection, sentence, clause, phrase or portion of this ordinance is for any reason held to be invalid or unconstitutional by a court of competent jurisdiction, such portion shall be deemed a separate, distinct and independent provision, and such holding shall not affect the validity of the remaining portions hereof.
