

ORDINANCE NO. 2021 – 17

AN ORDINANCE OF THE TOWNSHIP OF LITTLE EGG HARBOR, COUNTY OF OCEAN, STATE OF NEW JERSEY, AUTHORIZING THE ACQUISITION OF BLOCK 124, LOTS 69 AND 70 ON THE TAX MAPS OF THE TOWNSHIP OF LITTLE EGG HARBOR IN ACCORDANCE WITH N.J.S.A. 40A:12-3 ET SEQ.

WHEREAS, N.J.S.A. 40A:12-4 and -5 enables a municipality to adopt an ordinance to acquire real property in the Township by purchase for municipal public purpose; and

WHEREAS, the Township of Little Egg Harbor is desirous of acquiring the property located on Block 124, Lot 69 and 70, also known as 1371 and 1375 Route 539, adjacent to the Township Public Works on Route 539; and

WHEREAS, the parties have agreed upon a purchase price of \$80,000.00 for both properties (exclusive of closing costs), which is less than the current assessed value of the properties; and

WHEREAS, the governing body desires to authorize the purchase of said real property as in the public interest.

NOW, THEREFORE, BE IT ORDAINED, by the governing body of the Township of Little Egg Harbor, County of Ocean, State of New Jersey, as follows:

SECTION 1. That the governing body does hereby authorize the purchase of property located on Block 124, Lot 69 and 70, also known as 1371 and 1375 Route 539, adjacent to the Township Public Works on Route 539, from the Seller, Jane Butensky, for an amount not to exceed \$80,000.00, exclusive of closing costs.

SECTION 2. The Mayor is authorized to execute and the Township Clerk to attest to a Contract for Sale on Block 124, Lot 69 and 70 in accordance with the terms of this Ordinance, in a form acceptable to the Township Attorney.

SECTION 3. The Mayor is further authorized to execute and the Township Clerk to attest to any and all documentation necessary to effectuate the acquisition and closing of title of said real property, the form and type of documentation as acceptable to the Township Attorney.


SECTION 4. This ordinance shall take effect after second reading and publication as required by law.
