

RESOLUTION NO. 2018-118

RESOLUTION OF THE TOWNSHIP OF LITTLE EGG HARBOR, COUNTY OF OCEAN, STATE OF NEW JERSEY, AMENDING RESOLUTION 2017-193 AUTHORIZING THE SHARED SERVICES AGREEMENT WITH THE COUNTY OF OCEAN FOR THE DRIVING WHILE INTOXICATED ENFORCEMENT PROGRAM

WHEREAS, the Shared Services Consolidation Act, N.J.S.A. 40A:65-1 et seq., authorizes the Township of Little Egg Harbor to enter into a contract for the provision of certain governmental services with the County of Ocean; and

WHEREAS, N.J.S.A. 40A:65-5 requires such a contract to be authorized by resolution or ordinance; and

WHEREAS, the governing body previously authorized the execution of a Shared Services Agreement with the County of Ocean for the Driving While Intoxicated Enforcement Program for 2017/2018 via Resolution 2017-193; and

WHEREAS, Resolution 2017-193 requires amendment to increase the reimbursement rate for officers called upon to assist in DWI programs from \$55.00 per hour to \$70.00 per hour from the DWI grant designated by the State of New Jersey, the Ocean County Prosecutor's Office and Board of Chosen Freeholders; and

WHEREAS, it is the desire of the governing body to amend 2017-193 to reflect the proper reimbursement rate.

NOW, THEREFORE, BE IT RESOLVED by the Mayor and Township Committee of the Township of Little Egg Harbor, County of Ocean, State of New Jersey, as follows:

1. That Resolution 2017-193 is hereby amended to reflect that the reimbursement rate for officers called upon to assist in DWI programs from the DWI grant designated by the State of New Jersey, the Ocean County Prosecutor's Office and Board of Chosen Freeholders shall be increased from \$55.00 to \$70.00 per hour.

2. A certified copy of this resolution shall be forwarded to the Ocean County Prosecutor's Office, the Little Egg Harbor Police Department and the Chief Financial Officer.
