RESOLUTION OF THE TOWNSHIP OF LITTLE EGG HARBOR, COUNTY OF OCEAN, STATE OF NEW JERSEY AUTHORIZING THE RENEWAL OF PLENARY RETAIL CONSUMPTION AND PLENARY RETAIL DISTRIBUTION LICENSES FOR THE 2018-2019 LICENSING YEAR

WHEREAS, the current Plenary Retail Consumption and Plenary Retail Distribution License holders have filed their renewal applications for the fiscal year July 1, 2018 - June 30, 2019. GMG Inc.
