

RESOLUTION NO. 2018 – 151

RESOLUTION OF THE TOWNSHIP OF LITTLE EGG HARBOR, COUNTY OF OCEAN, STATE OF NEW JERSEY, AUTHORIZING THE EXECUTION OF A COLLECTIVE BARGAINING AGREEMENT WITH DEPARTMENT HEADS, AFSCME COUNCIL 71

WHEREAS, the previous Employment Agreement with the Department Heads, AFSCME Council 71 expired on December 31, 2014; and

WHEREAS, the parties came to an agreement with regard to the terms and conditions of the collective bargaining agreement and memorialized the same in a Memorandum of Agreement; and

WHEREAS, pursuant to Resolution 2016-174, the Township Committee approved the Memorandum of Agreement; and

WHEREAS, pursuant to Resolution 2017-104, the Township Committee authorized the execution of the Collective Bargaining Agreement; and

WHEREAS, it was brought to the Township's attention that there was an issue in the incorporation of the Memorandum of Agreement into the Collective Bargaining Agreement; and

WHEREAS, the Union has requested that the parties correct the incorporation issue and revise the Collective Bargaining Agreement; attached hereto and incorporated herein; and

WHEREAS, the governing body wishes to ratify and authorize the execution of the collective bargaining agreement with the Department Heads, AFSCME Council 71.

NOW, THEREFORE, BE IT RESOLVED, by the governing body of the Township of Little Egg Harbor, County of Ocean, State of New Jersey as follows:

1. That the governing body does hereby authorize the execution of a collective bargaining agreement with the Department Heads, AFSCME Council 71 for the term of January 1, 2015 to December 31, 2018.

2. That the Deputy Mayor is hereby authorized to execute and the Township Clerk to attest to the Collective Bargaining Agreement with the AFSCME Council 71 and the Township.

3. That this resolution shall take effect immediately.

4. That a certified copy of this resolution shall be forwarded to the AFSCME Council 71 and the Chief Financial Officer.
