

RESOLUTION NO. 2018 – 167

RESOLUTION OF THE TOWNSHIP OF LITTLE EGG HARBOR, COUNTY OF OCEAN, STATE OF NEW JERSEY, AWARDING A CONTRACT FOR THE OSBORN ISLAND MAINTENANCE DREDGING PROJECT

WHEREAS, the Township of Little Egg Harbor duly advertised for a contractor for the Osborn Island Maintenance Dredging Project; and

WHEREAS, in response to the invitation to bidders, five (5) bids were received on July 10, 2018; and

WHEREAS, the bids have been reviewed by the Township Engineer, the Township Administrator and the Township Attorney and it has been determined that Wickberg Marine Contracting of Belford, NJ submitted the lowest responsible bid in accordance with the bid specifications, said bid being \$1,328,848.00; and

WHEREAS, it is the desire of the governing body to award a contract for the Osborn Island Maintenance Dredging Project to Wickberg Marine Contracting.

NOW, THEREFORE, BE IT RESOLVED, by the governing body of the Township of Little Egg Harbor, County of Ocean, State of New Jersey, as follows:

1. That the governing body does hereby award a contract for the Osborn Island Maintenance Dredging Project to Wickberg Marine Contracting.
2. That the Mayor and Township Clerk are hereby authorized to execute a contract with Wickberg Marine Contracting in accordance with that company's bid submission.
3. That the governing body specifically approves the bid specifications prepared in connection with the Osborn Island Maintenance Dredging Project.

4. That a certificate of availability of funds executed by the Chief Financial Officer is annexed hereto. The following are the line item appropriations or ordinances which constitute the availability of funds for this contract:
