

**RESOLUTION NO. 2018 – 168**

**RESOLUTION OF THE TOWNSHIP OF LITTLE EGG HARBOR, COUNTY OF OCEAN, STATE OF NEW JERSEY, AUTHORIZING THE INTERVIEW AND RECOMMENDATION REGARDING HIRE OF A POLICE OFFICER**

**WHEREAS**, there is a need for the hiring of a police officer for the Township of Little Egg Harbor Police Department; and

**WHEREAS**, the governing body previously authorized the interview and hire of an applicant by Resolution 2018-82 for a candidate to commence employment on March 16, 2018, however the prospective officer was never hired; and

**WHEREAS**, Police Chief Richard Buzby has recommended another specific applicant to the governing body for a conditional offer of employment with the Township Police Department; and

**WHEREAS**, the offer of employment is expressly conditioned on the applicant's successful completion and approval of a satisfactory background check, physical and psychological examinations as well as any other examinations and evaluations recommended by the Chief of Police; and

**WHEREAS**, due to privacy concerns, the applicant's name is withheld from this resolution to protect the applicant's medical information; and

**WHEREAS**, the salary for the police officer shall be in accordance with the salary ordinance in effect at the time of the hearing.

**NOW, THEREFORE, BE IT RESOLVED**, by the Township Committee of the Township of Little Egg Harbor, County of Ocean, State of New Jersey as follows:

1. That the governing body hereby authorizes a conditional offer of employment to the applicant, as a full-time police officer with the Township of Little Egg Harbor Police Department.
2. That the employment set forth herein shall have a commencement date of September 12, 2018 subject to the satisfaction of all conditions and requirements set forth in this resolution.
3. That the employment shall be contingent and conditioned upon the completion and approval of a satisfactory background check, physical and psychological examination as well as any other examinations and evaluations recommended by the Chief of Police.
4. The applicant shall be compensated in accordance with the salary ordinance and Collective Bargaining Agreement between the Township of Little Egg Harbor and the Policeman's Benevolent Association, Local 295.
5. That a certified copy of this resolution shall be forwarded by the Municipal Clerk to the Township Administrator and Chief of Police.
