

**RESOLUTION NO. 2018- 197**

**RESOLUTION OF THE TOWNSHIP OF LITTLE EGG HARBOR, COUNTY OF OCEAN, STATE OF NEW JERSEY, AWARDED A CONTRACT FOR THE IOWA COURT AND SOUTH GREEN STREET LIVING SHORELINES PROJECT**

**WHEREAS**, the Township of Little Egg Harbor duly advertised for a contractor for the Iowa Court and South Green Street Living Shorelines Project; and

**WHEREAS**, in response to the invitation to bidders, three (3) bids were received on August 17, 2018; and

**WHEREAS**, the bids have been reviewed by the Township Engineer, the Township Administrator and the Township Attorney and it has been determined that Albert Marine Construction of Waretown, NJ submitted the lowest responsible bid in accordance with the bid specifications, said bid being \$1,086,031.75 for Base Bid A and \$421,036.00 for Base Bid B for a total bid of \$1,507,067.75; and

**WHEREAS**, it is the desire of the governing body to award a contract for the Iowa Court and South Green Street Living Shorelines Project to Albert Marine Construction.


**NOW, THEREFORE, BE IT RESOLVED**, by the governing body of the Township of Little Egg Harbor, County of Ocean, State of New Jersey, as follows:

1. That the governing body does hereby award a contract for the Iowa Court and South Green Street Living Shorelines Project to Albert Marine Construction.
2. That the Mayor and Township Clerk are hereby authorized to execute a contract with Albert Marine Construction in accordance with that company's bid submission of \$1,086,031.75 for Base Bid A and \$421,036.00 for Base Bid B for a total bid of \$1,507,067.75.

3. That the governing body specifically approves the bid specifications prepared in connection with the Iowa Court and South Green Street Living Shorelines Project.
4. That a certificate of availability of funds executed by the Chief Financial Officer is annexed hereto. The following are the line item appropriations or ordinances which constitute the availability of funds for this contract:
