**RESOLUTION OF THE TOWNSHIP OF LITTLE EGG HARBOR,  
COUNTY OF OCEAN, STATE OF NEW JERSEY, AUTHORIZING  
AND DESIGNATING PUBLIC AGENCY COMPLIANCE  
OFFICERS FOR THE TOWNSHIP OF LITTLE EGG HARBOR IN  
ACCORDANCE WITH N.J.A.C. 17:27-3.3**

**WHEREAS**, each public agency shall annually designate an officer or employee who may be existing officer or employee to serve as a Public Agency Compliance Officer in accordance with N.J.A.C. 17:27-3.2; and

**WHEREAS**, the Public Agency Compliance Officer shall perform the duties prescribed in the rules regarding general requirements for public agencies awarding contracts delineated within N.J.A.C. 17:27-3.1 to 3.9; and

**WHEREAS**, the Public Agency Compliance Officer shall be responsible for ensuring the Municipality's compliance with the rules shall perform any of the liaison and assistance functions as may be requested by the Division of Contract Compliance and Equal Employment Opportunity in Public Contracts established in the State of New Jersey Department of Treasury; and

**WHEREAS**, the governing body desires to appoint Garrett Loesch and Carolyn Crowley as Public Agency Compliance Officers for the Township of Little Egg Harbor.

**NOW, THEREFORE, BE IT RESOLVED**, by the governing body of the Township of Little Egg Harbor, County of Ocean, State of New Jersey as follows:

1. That the governing body hereby designates Garrett Loesch and Carolyn Crowley as Public Agency Compliance Officers for the Township of Little Egg Harbor in accordance with N.J.A.C. 17:27-3.3

2. That the Division of Contract Compliance and Equal Employment Opportunity in Public Contracts in the State of New Jersey Department of Treasury shall be notified of this designation by the Township of Little Egg Harbor by January 1, 2018.

3. That a certified copy of this resolution shall be forwarded to the Township Administrator, Garrett Loesch, Carolyn Crowley, and the Division of Contract Compliance and Equal Employment Opportunity in Public Contracts in the State of New Jersey Department of Treasury.
