RESOLUTION OF THE TOWNSHIP OF LITTLE EGG HARBOR, COUNTY OF OCEAN, STATE OF NEW JERSEY AUTHORIZING THE COMPENSATION OF UNUSED SICK TIME TO LAUREN ROMANO

WHEREAS, Lauren Romano has submitted her resignation from the Township as of September 6, 2016; and

WHEREAS, as of the date of his retirement, Lauren Romano will have accumulated 863.00 hours of unused sick time over the course of her employment with the Little Egg Harbor Township; and

WHEREAS, pursuant to the Collective Bargaining Agreement governing Ms. Romano's position, she is entitled to be paid for her accumulated unused sick time at 50% of her current rate of pay; and

WHEREAS, the said total to be paid to Lauren Romano for the accumulated sick leave is \$6,933.69; and

NOW, THEREFORE, BE IT RESOLVED, by the governing body of the Township of Little Egg Harbor, County of Ocean, State of New Jersey as follows:

1. That the governing body does hereby authorize the payment to Lauren Romano in the amount of \$6,933.69 representing her unused sick leave.
2. That a certified copy of this resolution shall be forwarded Lauren Romano, the Civil Service Commission, and the Chief Financial Officer.
