**RESOLUTION OF THE TOWNSHIP OF LITTLE EGG HARBOR, COUNTY OF OCEAN, STATE OF NEW JERSEY, AWARDING A CONTRACT TO THE RODGERS GROUP, LLC FOR ONLINE IN-SERVICE TRAINING FOR THE POLICE DEPARTMENT**

**WHEREAS**, Little Egg Harbor Township is in need of on-line in-service training services to assist in retaining accreditation from the New Jersey State Association of Chiefs of Police, to ensure compliance with New Jersey State Association of Chiefs of Police standards and the Attorney General's Guidelines; and

**WHEREAS**, the services are specialized and qualitative in nature requiring expertise, extensive training and proven reputation in the field of endeavor, in this instance the field of police accreditation, and it has been determined by Lt. Hawkins of the Police Department, who had also attempted to obtain quotes for the service, that as such the needed service is an Extraordinary Unspecifiable Service pursuant to N.J.S.A. 40A:11-5(1)(a)(ii), and does not require public bidding; and

**WHEREAS**, the annual amount of this contract shall be \$11,520.00, which annual price shall be held for the term of such contract, which term shall be for two years with an option to renew for a third year; and

**NOW, THEREFORE, IT IS RESOLVED** by the Township Council of the Township of Little Egg Harbor, as follows:

1. The Mayor and Township Clerk are hereby authorized to execute and attest, respectively, to the contract in an annual amount not to exceed \$11,520.00 with THE RODGERS GROUP, LLC as described herein.
