

**RESOLUTION NO. 2018 – 83**

**RESOLUTION OF THE TOWNSHIP OF LITTLE EGG HARBOR, COUNTY OF OCEAN, STATE OF NEW JERSEY, AUTHORIZING THE EXECUTION OF A CHANGE ORDER TO THE CONTRACT FOR THE FY2017 NJDOT MUNICIPAL AID ROAD PROGRAM FOR IMPROVEMENTS TO PINEHURST DRIVE AND SEMINOLE DRIVE**

WHEREAS, a contract was previously awarded to Arawak Paving Co. Inc. for the FY 2017 NJDOT Municipal Aid Road Program for Improvements to Pinehurst Drive and Seminole Drive; and

WHEREAS, the original contract for said improvements was in the amount of \$414,7000.00; and

WHEREAS, the governing body wishes to authorize Change Order No. 1, which will result in an increase of \$51,904.46 and a reduction of \$34,440.00 for a net increase of \$17,464.46 in the contract price, representing final as-built quantity adjustments as shown on Schedule A attached hereto and made a part hereof; and

WHEREAS, this change order has been recommended by the Township Engineer; and

WHEREAS, it is the desire of the governing body to authorize the execution of this change order.

**NOW, THEREFORE, BE IT RESOLVED**, by the governing body of the Township of Little Egg Harbor, County of Ocean, State of New Jersey as follows:

1. That the governing body does hereby authorize the execution of Change Order No. 1, which will result in an increase of \$51,904.46 and a reduction of \$34,440.00 for a net

increase of \$17,464.46 in the contract price from \$414,7000.00 to \$432,164.46 representing final as-built quantity adjustments as shown on Schedule A attached hereto and made a part hereof.

2. That the Mayor is hereby authorized to execute and the Township Clerk to attest to, respectively, an addendum to the contract with Arawak Paving Co. Inc., in accordance with the provisions of this resolution.

3. That a certified copy of this resolution, together with a copy of Change Order No. 1, be forwarded to the Chief Financial Officer and Arawak Paving Co. Inc.
