

**RESOLUTION NO. 2019 – 104**

**RESOLUTION OF THE TOWNSHIP OF LITTLE EGG HARBOR, COUNTY OF OCEAN, STATE OF NEW JERSEY, AWARDING A CONTRACT FOR THE FY 2018 MUNICIPAL AID ROAD PROGRAM – IMPROVEMENTS TO MARYLAND ROAD TO EARLE ASPHALT COMPANY**

**WHEREAS**, the Township of Little Egg Harbor duly advertised for the receipt of bids for the FY 2018 Municipal Aid Road Program – Improvements to Maryland Road; and

**WHEREAS**, in response to the invitation to bidders, five (5) bids were received on April 4, 2019 and

**WHEREAS**, the bids have been reviewed by the Township Attorney and the Township Engineer and it has been determined that Earle Asphalt Company submitted the lowest responsible and responsive bid in accordance with the bid specifications, said bid being \$402,913.13; and

**WHEREAS**, it is the desire of the governing body to award a contract for the FY 2018 Municipal Aid Road Program – Improvements to Maryland Road to Earle Asphalt Company.

**NOW, THEREFORE, BE IT RESOLVED**, by the governing body of the Township of Little Egg Harbor, County of Ocean, State of New Jersey as follows:

1. That the governing body does hereby award a contract to Earle Asphalt Company, the lowest responsible and responsive bidder, for the FY 2018 Municipal Aid Road Program – Improvements to Maryland Road at \$402,913.13, subject to the review and approval of the New Jersey Department of Transportation.

2. That the Mayor and the Township Clerk are hereby authorized to execute a contract with Earle Asphalt Company, in accordance with the bid submitted by Earle Asphalt Company.

3. That the governing body specifically approves the bid specifications, designs and plans prepared in connection with the construction of the FY 2018 Municipal Aid Road Program – Improvements to Maryland Road.

4. That a Certificate of Availability of Funds executed by the Chief Financial Officer is annexed hereto. The following are the line item appropriations or ordinances which constitute the availability of funds for this contract:
