**RESOLUTION OF THE TOWNSHIP OF LITTLE EGG
HARBOR, COUNTY OF OCEAN, STATE OF NEW
JERSEY, AUTHORIZING THE EXECUTION OF A
CONTRACT UNDER THE H-GAC COMMISSION
COOPERATIVE PURCHASING SYSTEM
(Contract #AM10-18)**

WHEREAS, the Township of Little Egg Harbor intends to participate in the H-GAC Commission Cooperative Purchasing System program to purchase under a National Cooperative Purchasing Agreement one (1) Ford E450 (gas) Type III Base Ambulance Remount with options; and

WHEREAS, pursuant to N.J.S.A. 52:34-6.2(b)(3), Little Egg Harbor may by resolution and without advertising for bids, purchase any good or services under a national cooperative purchasing agreement; and

WHEREAS, the Township of Little Egg Harbor desires to enter into a contract with VCI Emergency Vehicle Specialists under H-GAC, Contract #AM10-18, to purchase an ambulance for Great Bay Regional EMS; and

WHEREAS, the Township of Little Egg Harbor anticipates joining the H-GAC contract on July 1, 2019 and is required to publish the Notice of Intent once in the official newspaper of the Township of Little Egg Harbor; and

WHEREAS, the Chief Financial Officer of the Township of Little Egg Harbor has certified as to the availability of funds for this purchase.

NOW, THEREFORE, BE IT RESOLVED, by the governing body of the Township of Little Egg Harbor, County of Ocean, State of New Jersey, as follows:

1. That the governing body does hereby authorize the purchase of one (1) Ford E450 (gas) Type III Base Ambulance Remount with options for a total purchase price (E+F+G) of \$149,999.00 from VCI Emergency Vehicle Specialists under H-GAC Contract #AM10-18.
2. That the Notice of Intent shall be published once in the official newspaper of the Township of Little Egg Harbor.
3. That the Mayor is hereby authorized to execute and the Township Clerk to attest to an agreement with VCI Emergency Vehicle Specialists and any other documents necessary to effectuate the terms of this resolution.

4. That a Certificate of Availability of Funds executed by the Chief Financial Officer is annexed hereto. The following are the line item appropriations or ordinances which constitute the availability of funds for this contract: 9-01-25-750-109 \$25,000.⁰⁰

5. That a certified copy of this resolution shall be forwarded to the Chief Financial Officer and VCI Emergency Vehicle Specialists.
