**RESOLUTION OF THE TOWNSHIP OF LITTLE EGG HARBOR,
COUNTY OF OCEAN, STATE OF NEW JERSEY, AWARDING A
CONTRACT FOR THE DEMOLITION OF CERTAIN STRUCTURES**

WHEREAS, the Township of Little Egg Harbor duly advertised for the receipt of bids for the demolition of all structures located at 45 Sea Breeze Drive (Block 172.02, Lot 8); 252 Country Club Boulevard (Block 326.0), Lot 1); and 110 National Union Boulevard (Block 325.26, Lot 30); and

WHEREAS, in response to the invitation to bidders, five (5) bids were received on June 26, 2019 and

WHEREAS, the bids have been reviewed by the Township Attorney and the Township Engineer and it has been determined that Mathis Construction Co. Inc. submitted the lowest responsible and responsive bid in accordance with the bid specifications, said bid being \$70,120.00; and

WHEREAS, it is the desire of the governing body to award a contract for the Demolition of Structures located at 45 Sea Breeze Drive, 252 Country Club Boulevard and 110 National Union Boulevard to Mathis Construction Co. Inc..

NOW, THEREFORE, BE IT RESOLVED, by the governing body of the Township of Little Egg Harbor, County of Ocean, State of New Jersey as follows:

1. That the governing body does hereby award a contract to Mathis Construction Co. Inc. the lowest responsible and responsive bidder, for the Demolition of Structures located at 45 Sea Breeze Drive, 252 Country Club Boulevard and 110 National Union Boulevard in the amount of \$70,120.00.
2. That the Mayor and the Township Clerk are hereby authorized to execute a contract with Mathis Construction Co. Inc. in accordance with the bid submitted by Mathis Construction Co. Inc.
3. That the governing body specifically approves the bid specifications, designs and plans prepared in connection with the Demolition of Structures located at 45 Sea Breeze Drive, 252 Country Club Boulevard and 110 National Union Boulevard.
4. That a Certificate of Availability of Funds executed by the Chief Financial Officer is annexed hereto. The following are the line item appropriations or ordinances which constitute the availability of funds for this contract: _____
