

RESOLUTION NO. 2019 – 152

RESOLUTION OF THE TOWNSHIP OF LITTLE EGG HARBOR, COUNTY OF OCEAN, STATE OF NEW JERSEY, AWARDING A CONTRACT FOR THE 2019 DRAINAGE IMPROVEMENTS TO EARLE ASPHALT COMPANY

WHEREAS, the Township of Little Egg Harbor duly advertised for the receipt of bids for the 2019 Drainage Improvements; and

WHEREAS, in response to the invitation to bidders, four (4) bids were received on July 2, 2019 and

WHEREAS, the bids have been reviewed by the Township Attorney and the Township Engineer and it has been determined that Earle Asphalt Company submitted the lowest responsible and responsive bid in accordance with the bid specifications, said bid being \$180,013.13; and


WHEREAS, it is the desire of the governing body to award a contract for the 2019 Drainage Improvements to Earle Asphalt Company.

NOW, THEREFORE, BE IT RESOLVED, by the governing body of the Township of Little Egg Harbor, County of Ocean, State of New Jersey as follows:

1. That the governing body does hereby award a contract to Earle Asphalt Company, the lowest responsible and responsive bidder, for the 2019 Drainage Improvements at \$180,013.13.
2. That the Mayor and the Township Clerk are hereby authorized to execute a contract with Earle Asphalt Company, in accordance with the bid submitted by Earle Asphalt Company.
3. That the governing body specifically approves the bid specifications, designs and plans prepared in connection with the construction of the 2019 Drainage Improvements.
4. That a Certificate of Availability of Funds executed by the Chief Financial Officer is annexed hereto. The following are the line item appropriations or ordinances which constitute the availability of funds for this contract: _____
