**RESOLUTION OF THE TOWNSHIP OF LITTLE EGG HARBOR,  
COUNTY OF OCEAN, STATE OF NEW JERSEY, AWARDING A  
CONTRACT FOR THE VETERANS PARK PHASE 2 PROJECT**

**WHEREAS**, the Township of Little Egg Harbor duly advertised for the receipt of bids for the Veterans Park -Phase 2 Project; and

**WHEREAS**, in response to the invitation to bidders, five (5) bids were received on July 9, 2019 and

**WHEREAS**, the bid was broken down into the Base Bid and six Alternate Bids and the Township Committee wishes to award a contract for the Base Bid and Alternate Bids A, C, D and F; and

**WHEREAS**, the bids have been reviewed by the Township Attorney and the Township Engineer and it has been determined Sussman Enterprises submitted the lowest responsible and responsive bid in accordance with the bid specifications for the Base Bid and Alternate Bids A, C, D and F in the amount of \$303,582.50; and

**WHEREAS**, it is the desire of the governing body to award a contract for Veterans Park-Phase 2 Project for the Base Bid and Alternate Bids A, C, D and F to Sussman Enterprises.

**NOW, THEREFORE, BE IT RESOLVED**, by the governing body of the Township of Little Egg Harbor, County of Ocean, State of New Jersey as follows:

1. That the governing body does hereby award a contract to Sussman Enterprises, the lowest responsible and responsive bidder, for the Veterans Park - Phase 2 Project for the Base Bid and Alternate Bids A, C, D and F in the amount of \$303,582.50
2. That the Mayor and the Township Clerk are hereby authorized to execute a contract with Sussman Enterprises, in accordance with the bid submitted by Sussman Enterprises.
3. That the governing body specifically approves the bid specifications, designs and plans prepared in connection with the construction of the Veterans Park-Phase 2 Project.
