

RESOLUTION NO. 2019-201

RESOLUTION OF THE TOWNSHIP OF LITTLE EGG HARBOR, COUNTY OF OCEAN, STATE OF NEW JERSEY, AUTHORIZING THE TAX COLLECTOR TO RE-INSTATE TAXES ON PROPERTY PREVIOUSLY QUALIFIED FOR VETERANS' PROPERTY TAX EXEMPTION (JOHN H. KUPER, BLOCK 285.11, LOT 10.16)

WHEREAS, N.J.S.A. 54:4-3.30 provides for an exemption from taxes on certain property owned by a totally-disabled veteran; and

WHEREAS, it was previously determined by the Tax Assessor that property known as Block 285.11, Lot 10.16, owned by John H. Kuper, qualified for a Veterans' Property Tax Exemption as of 2003; and

WHEREAS, it has come to the attention of the Township that the property is not entitled to the Exemption as of 2010; and

WHEREAS, the Township desires to authorize the Tax Collector to re-instate taxes for Block 285.11, Lot 10.16 as of tax year 2010 per the attached schedule A.

NOW, THEREFORE, BE IT RESOLVED, by the governing body of the Township of Little Egg Harbor, County of Ocean, State of New Jersey as follows:


1. That the Mayor and Township Committee do hereby authorize the Tax Collector to re-instate the taxes for Block 285.11, Lot 10.16, owned by John H. Kuper, as of tax year 2010, as said property does not qualify for a Veterans' Property Tax Exemption under N.J.S.A. 54:4-3.30.

2. That the Tax Collector is authorized to waive the interest associated with the re-instatement.

3. That a certified copy of this resolution shall be forwarded by the Municipal Clerk to the Tax Collector, the Tax Assessor and the Chief Financial Officer of the Township of Little Egg Harbor.
