

RESOLUTION NO. 2019 – 208

RESOLUTION OF THE TOWNSHIP OF LITTLE EGG HARBOR, COUNTY OF OCEAN, STATE OF NEW JERSEY, AUTHORIZING THE SALE OF SURPLUS PROPERTY NO LONGER NEEDED FOR PUBLIC USE ON AN ON-LINE AUCTION WEBSITE, “WWW.GOVDEALS.COM”

WHEREAS, the Township of Little Egg Harbor has determined that the surplus property is no longer needed for public use; and

WHEREAS, the Department of Community Affairs, State of New Jersey permits the sale of surplus property no longer needed for public use through the use of an on-line auction service pursuant to the Local Unit Electronic Technology Pilot Program and Study Act, P.L. 2001, c. 30; and

WHEREAS, the surplus property no longer needed for public use is listed on the attached Schedule “A” wherein the governing body desires to sell this property on-line at www.GovDeals.com.

NOW, THEREFORE, BE IT RESOLVED, by the governing body of the Township of Little Egg Harbor, County of Ocean, State of New Jersey as follows:

1. That the governing body does hereby authorizes the sale of the surplus property no longer needed by the Township for public use and listed on the attached Schedule “A”, by GovDeals, Inc.
2. The sale will be conducted online and the address of the auction site is govdeals.com.
3. The sale is being conducted pursuant to Local Finance Notice 2008-9.
4. The sale of surplus property shall be conducted through GovDeals pursuant to State Contract T2581 in accordance with the terms and conditions of the State

Contract. The terms and conditions of the agreement entered into with GovDeals are available online at govdeals.com and is available upon request from the Township Clerk.

5. That the Township Clerk shall prepare a notice for a newspaper publication announcing the auction and a general description of the items that will be sold online, indicating the internet address for the sale that is being advertised, including the date and time of the auction and a statement that bidders must pre-register with the approved vendor and the internet address with registration information.

6. That a certified copy of this resolution shall be forwarded to the Chief Financial Officer and the Department of Community Affairs.
