

RESOLUTION NO. 2019 - 58

RESOLUTION OF THE TOWNSHIP OF LITTLE EGG HARBOR, COUNTY OF OCEAN, STATE OF NEW JERSEY, CANCELLING TAXES AND AUTHORIZING REFUNDS PURSUANT TO N.J.S.A. 54:4-3.30

WHEREAS, N.J.S.A. 54:4-3.30 provides for an exemption from property taxes on certain property owned by totally-disabled United States Veterans; and

WHEREAS, it has been determined by the Tax Assessor that the properties located on the attached Schedules A-H qualify for a Veteran's Property Tax Exemption; and


WHEREAS, pursuant to N.J.S.A. 54:4-3.32 the Township Committee has the authority to cancel charges for a totally-disabled veterans portion of 2018 taxes when a N.J.S.A. 54:4-3.30 Certification of Assessment Credit for Exemption has been granted; and

WHEREAS, the Tax Collector deems that the property owners listed on the attached Schedules A-H should receive a refund on taxes already paid for the year 2018.

NOW, THEREFORE, BE IT RESOLVED, by the governing body of the Township of Little Egg Harbor, County of Ocean, State of New Jersey to hereby authorize Veteran's Property Tax Exemption discharge of debt for 2018 taxes. A certified copy of this resolution shall be forwarded to the Tax Collector.
