**RESOLUTION OF THE TOWNSHIP OF LITTLE  
EGG HARBOR, COUNTY OF OCEAN, STATE OF  
NEW JERSEY, AUTHORIZING APPROPRIATION  
TRANSFERS IN ACCORDANCE WITH N.J.S.A.  
40A:4-59**

**WHEREAS, N.J.S.A. 40A:4-59** provides that a governing body may within the first three months of the fiscal year transfer the amount of excess appropriations to those appropriations deemed to be insufficient; and

**WHEREAS,** such a transfer resolution must be authorized by not less than two-thirds vote of the full membership of the governing body; and

**WHEREAS,** the governing body of the Township of Little Egg Harbor has determined to authorize various transfers of appropriation as set forth on the attached Schedule A.


**NOW, THEREFORE, BE IT RESOLVED,** by the governing body of the Township of Little Egg Harbor, County of Ocean, State of New Jersey, as follows:

**A.** That the governing body hereby authorizes appropriation transfer in accordance with N.J.S.A. 40A:4-59 as set forth on the attached Schedule A.

**B.** That a copy of this resolution shall be served upon the Chief Financial Officer for the Township of Little Egg Harbor.
