

**RESOLUTION NO. 2019 – 70**

**RESOLUTION OF THE TOWNSHIP OF LITTLE EGG HARBOR, COUNTY OF OCEAN, STATE OF NEW JERSEY, AWARDED BID TO PURCHASE A 2020 OR NEWER MACK OR EQUAL GR64F WITH 25 CUBIC YARD REAR LOADER REFUSE TRUCK**

**WHEREAS**, the Township of Little Egg Harbor duly advertised for bid to purchase a 2020 or newer Mack or equal GR64F with 25 Cubic Yard Rear Loader Refuse Truck; and

**WHEREAS**, in response to the invitation to bidders, one (1) bid(s) were received on February 5, 2019; and

**WHEREAS**, the bid(s) have been reviewed by the Township Department of Public Works, the Township Administrator and the Township Attorney and it has been determined that Bergey's Trucks, Inc. submitted the lowest responsible bid in accordance with the bid specifications, said bid being \$254,980.00; and

**WHEREAS**, it is the desire of the governing body to award a contract for the 2020 or newer Mack or equal GR64F with 25 Cubic Yard Rear Loader Refuse Truck to Bergey's Trucks, Inc.

**NOW, THEREFORE, BE IT RESOLVED**, by the governing body of the Township of Little Egg Harbor, County of Ocean, State of New Jersey, as follows:

1. That the governing body does hereby award a contract for the 2020 or newer Mack or equal GR64F with 25 Cubic Yard Rear Loader Refuse Truck to Bergey's Trucks, Inc.
2. That the Mayor and Township Clerk are hereby authorized to execute a contract with Bergey's Trucks, Inc. in accordance with that company's bid submission of \$254,980.00.

3. That the governing body specifically approves the bid specifications prepared in connection with the 2020 or newer Mack or equal GR64F with 25 Cubic Yard Rear Loader Refuse Truck bid.
4. That a certificate of availability of funds executed by the Chief Financial Officer is annexed hereto. The following are the line item appropriations or ordinances which constitute the availability of funds for this contract:
