RESOLUTION OF THE TOWNSHIP OF LITTLE EGG HARBOR, COUNTY OF OCEAN, STATE OF NEW JERSEY AUTHORIZING THE PURCHASE OF NICE INFORM RECORDER EQUIPMENT FOR THE POLICE DEPARTMENT UNDER STATE CONTRACT #83909.

WHEREAS, the Little Egg Harbor Police Department is in need of new mobile radio logger and recording system; and

WHEREAS, the Township is able to purchase the required equipment under State Contract #83909 from Motorola Solutions Care of Allcomm Technologies, Inc. (“Motorola Solutions”) without the need for formal bidding; and

WHEREAS, Motorola Solutions provided a proposal via email dated November 6, 2018 for \$172,543.20 to provide the necessary equipment, installation, and training for the new radio equipment, the proposal is on file with the Township Clerk and can be viewed during normal business hours; and

WHEREAS, it is the desire of the governing body to award a contract for the new mobile radio logger and recording system to Motorola Solutions Care of Allcomm Technologies, Inc. pursuant to State Contract #83909;

NOW, THEREFORE, BE IT RESOLVED, by the governing body of the Township of Little Egg Harbor, County of Ocean, State of New Jersey, as follows:

1. That the governing body does hereby award a contract for the new mobile radio logger and recording system to Motorola Solutions Care of Allcomm Technologies, Inc. pursuant to State Contract #83909 at an amount not to exceed \$172,543.20 in accordance with the proposal submitted via email on November 6, 2018

2. That the Mayor and Township Clerk are hereby authorized to execute a contract with Motorola Solutions Care of Allcomm Technologies, Inc. in accordance with that company's bid submissions.
