

RESOLUTION NO. 2020 – 141

RESOLUTION OF THE TOWNSHIP OF LITTLE EGG HARBOR, COUNTY OF OCEAN, STATE OF NEW JERSEY, AUTHORIZING THE SUBMISSION OF A SUSTAINABLE JERSEY GRANT APPLICATION FOR AN ENVIRONMENTAL STEWARDSHIP GRANT

WHEREAS, it is in the public interest for the governing body of the Township of Little Egg Harbor to apply for an environmental stewardship grant in the amount of \$5,000 under the Sustainable Jersey Grant Program; and

WHEREAS, these grants are intended to help municipalities plan for, protect and improve public spaces such as local parks, natural areas, and recreation resources, and can be used in combination with other funding sources to cover a portion of the expenses associated with developing and/or supporting their open space programs not otherwise covered by state or county programs; and

WHEREAS, Township of Little Egg Harbor is a qualified municipality and is participating in the Sustainable Jersey Program; and

WHEREAS, the governing body has determined it is in the best interests of the Township to apply for this Sustainable Jersey environmental stewardship grant.

NOW, THEREFORE, BE IT RESOLVED, by the governing body of the Township of Little Egg Harbor, County of Ocean, State of New Jersey, as follows:

1. That the governing body does hereby authorize the submission of an application for an environmental stewardship grant in the amount of \$5,000 under the Sustainable Jersey Grant Program.
2. That the governing body further authorizes the Mayor to execute and the Clerk to attest to any documentation necessary to apply for said grant.
