

**RESOLUTION NO. 2020 – 173**

**RESOLUTION OF THE TOWNSHIP OF LITTLE EGG HARBOR, COUNTY OF OCEAN, STATE OF NEW JERSEY, AWARDING A CONTRACT FOR THE FENCE REPLACEMENT AT THE COMMUNITY CENTER TO ABHZEEN DESIGN**

**WHEREAS**, the Township of Little Egg Harbor duly advertised for the receipt of bids for the Fence Replacement at the Community Center; and

**WHEREAS**, in response to the invitation to bidders, three (3) bids were received on October 30, 2020 (Abhzeen Design - \$44,463.00; Premier Property - \$49,250.00 rejected due to a material defect on the consent of surety; and Accent Fence - \$59,750.00); and

**WHEREAS**, the bids have been reviewed by the Township Attorney and the Township Engineer and it has been determined that Abhzeen Design submitted the lowest responsible and responsive bid in accordance with the bid specifications, said bid being \$44,463.00; and

**WHEREAS**, it is the desire of the governing body to award a contract for the Fence Replacement at the Community Center to Abhzeen Design.

**NOW, THEREFORE, BE IT RESOLVED**, by the governing body of the Township of Little Egg Harbor, County of Ocean, State of New Jersey as follows:

1. That the governing body does hereby award a contract to Abhzeen Design, the lowest responsible and responsive bidder, for the Fence Replacement at the Community Center at \$44,463.00.
2. That the Mayor and the Township Clerk are hereby authorized to execute a contract with Abhzeen Design, in accordance with the bid submitted by Abhzeen Design.

3. That the governing body specifically approves the bid specifications, designs and plans prepared in connection with the construction of the Fence Replacement at the Community Center.


4. That a Certificate of Availability of Funds executed by the Chief Financial Officer is annexed hereto. The following are the line item appropriations or ordinances which constitute the availability of funds for this contract: 2019 COMMUNITY

DEVELOPMENT BLOCK GRANT / C-04-55-908-017

5. That a certified copy of this resolution, together with a copy of the contract between the parties, shall be forwarded to the Chief Financial Officer, the Township Engineer and Abhzeen Design.


