

RESOLUTION NO. 2020- 175

RESOLUTION OF THE TOWNSHIP OF LITTLE EGG HARBOR, COUNTY OF OCEAN, STATE OF NEW JERSEY, AUTHORIZING THE EXECUTION OF A CHANGE ORDER TO THE CONTRACT FOR THE FY 2019 NJDOT MUNICIPAL AID ROAD PROGRAM – IMPROVEMENTS TO GREAT BAY BOULEVARD

WHEREAS, a contract was previously awarded to Earle Asphalt Company for the FY 2019 NJDOT Municipal Aid Road Program – Improvements to Great Bay Boulevard; and

WHEREAS, the original contract for said improvements was in the amount of \$555,613.13; and

WHEREAS, the governing body wishes to authorize Change Order No. 1(Final), which will result in a net increase of \$27,983.56 in the contract price (5.04% increase), representing supplemental work and final as-built quantity adjustments as shown on Schedule A attached hereto and made a part hereof; and

WHEREAS, this change order has been recommended by the Township Engineer; and

WHEREAS, the increase is less than 20% of the original contract awarded to the contractor; and

WHEREAS, it is the desire of the governing body to authorize the execution of this change order.

NOW, THEREFORE, BE IT RESOLVED, by the governing body of the Township of Little Egg Harbor, County of Ocean, State of New Jersey as follows:

1. That the governing body does hereby authorize the execution of Change Order No. 1(Final), with Earle Asphalt Company for the FY 2019 NJDOT Municipal Aid

Road Program – Improvements to Great Bay Boulevard which will result in a net increase of \$27,983.56 in the contract price from \$555,613.13 to \$583,596.69, representing final as-built quantity adjustments as shown on Schedule A attached hereto and made a part hereof.

2. That the Mayor is hereby authorized to execute and the Township Clerk to attest to, respectively, an addendum to the contract with Earle Asphalt Company in accordance with the provisions of this resolution.
