RESOLUTION OF THE TOWNSHIP OF LITTLE EGG HARBOR, COUNTY OF OCEAN, STATE OF NEW JERSEY, AUTHORIZING CHIEF FINANCIAL OFFICER, RODNEY R. HAINES, TO RECEIVE AN ANNUAL STIPEND FOR PROVIDING SERVICES TO OCEAN TOWNSHIP (WARETOWN) UNDER A SHARED SERVICES AGREEMENT WITH OCEAN TOWNSHIP FOR FINANCE SERVICES

WHEREAS, pursuant to N.J.S.A. 40A:65-1 et seq., the Township of Little Egg Harbor has authorized by Resolution the execution of a shared services agreement with Ocean Township (Waretown) for financial services by the Township of Little Egg Harbor to the Township of Ocean, retroactive to December 1, 2020; and

WHEREAS, the Township of Little Egg Harbor will receive \$60,000 annually from Ocean Township (Waretown) as consideration for providing financial services by the Township of Little Egg Harbor's Chief Financial Officer; and

WHEREAS, it is the desire of the governing body to pay a stipend to the Township of Little Egg Harbor's Chief Financial Officer, Rodney R. Haines, for the additional work of providing the financial services to Ocean Township (Waretown) through the aforementioned shared services agreement.

NOW, THEREFORE, BE IT RESOLVED, by the governing body of the Township of Little Egg Harbor, County of Ocean, State of New Jersey as follows:

1. That the governing body does hereby authorize the payment to Chief Financial Officer, Rodney R. Haines, of an annual stipend of \$36,000.00, sourced from the payment from Ocean Township (Waretown) for providing financial services under the shared services agreement to Ocean Township (Waretown). Said stipend shall be paid in monthly payments of

\$3,000.00 as of December 1, 2020. If the shared services agreement is renewed for an additional one (1) year term by written agreement of the Township of Little Egg Harbor and Ocean Township (Waretown), the annual stipend to the Chief Financial Officer, Rodney R. Haines, shall be \$36,720.00 for the additional one (1) year term from December 1, 2021 to November 30, 2022, payable in monthly installments of \$3,060.00. Said stipend shall only be payable so long as the shared services agreement with Ocean Township (Waretown) is in effect and shall cease to accrue upon termination of said shared services agreement.

2. That a certified copy of this resolution be forwarded to Little Egg Harbor Township Administrator and Rodney R. Haines.
