**RESOLUTION OF THE TOWNSHIP OF LITTLE EGG HARBOR, COUNTY OF OCEAN, STATE OF NEW JERSEY, PROVIDING DATES FOR TOWNSHIP COMMITTEE MEETINGS AND DESIGNATING OFFICIAL NEWSPAPERS FOR THE YEAR 2020**

**WHEREAS**, the Open Public Meetings Act of 1976 requires public bodies to provide notice of all meetings in an effort to enhance the proper functioning of the democratic process; and
